(Scope of Application)

Article 1 This Form and Method of Grading Labels shall be applied to Grade labeling for Foods and Drinks, Oils and Fats listed in Attached Table 1, Attached Table 2, Attached Table 3, Attached Table 4, Attached Table 5, and Attached Table 6.

(Form of Labels)

Article 2 The form of Labels shall be in the Attached Form No. 1 in case of Foods and Drinks, Oils and Fats listed in Attached Table 1, in the Attached Form No. 2 in case of Foods and Drinks, Oils and Fats listed in Attached Table 2, in the Attached Form No. 3 in case of Foods and Drinks, Oils and Fats listed in Attached Table 3, in the Attached Form No. 4 in case of Foods and Drinks, Oils and Fats listed in Attached Table 4, in the Attached Form No. 5 in case of Foods and Drinks, Oils and Fats listed in Attached Table 5, or in the Attached Form No. 6 in case of Foods and Drinks, Oils and Fats listed in Attached Table 5, or in the Attached Form No. 6 in case of Foods and Drinks, Oils and Fats listed in Attached Table 6.

(Method of Labels)

Article 3 The Labels shall be attached on conspicuous part of each package or container or invoice.



Name of Certifying body Code number of certified body

- (1) A shall be longer than or equal to 5mm.
- (2) B shall be twice as long as A. D shall be three-tenths of C.
- (3) The height of names of Certifying Bodies shall be the same as D.
- (4) The names of Certifying Bodies can be described as abbreviated names.
- (5) The code number of certified body can be omitted if production process managers, re-packers, overseas production process managers or overseas re-packers for organic plants or organic livestock products or importers for specified agricultural and forestry products can be identified by the matter labeled on packages, containers or invoices of foods, drink products, fats and oils in accordance with applicable laws and regulations.
